Requirements of membership:

Regular - Regular members must be full-time or retired law enforcement officers/agents with a Federal, State or local governmental agency who supervise full-time law enforcement officers or agents, and must have the authority to write evaluations on performance and have the authority to administer discipline.

Associate - Associate members must have police/federal officer/agent authority with a Federal, State or Local governmental agency. Associate members can include seasonal, auxiliary, and other reserve status personnel, but must have the required sworn authority.

Corporate - Corporate sponsorships are organizations that support the mission and goals of NAAALEC with donations that may include services, products and currency.

All applications require a sponsor that is a regular NAAALEC member and expire on June 30th of every year.

Membership is contingent upon passing a background investigation with the approval of two board members. The background will be conducted to determine solely if the membership requirements are met and you are a person of good moral character.

NAAALEC has the right to deny, cancel or change (the type of) membership for any reason at any time.

NAAALEC welcomes all eligible persons to apply and does not discriminate membership based upon religion, ethnic origin, age, gender or sexual orientation.
